

1. Welcome

Thank you for choosing Cheapa Campa for your vehicle rental requirements. We are very proud of our product and our reputation. We have built our business on providing the best possible experience for our customers. Your safety and security are our greatest concerns, so to assist in your holiday being a wonderful experience, it is important for you to carefully read and understand the following information.

2. Agreement

This is an Agreement between You ('You' includes any additional renters identified in **Rental Vehicle Agreement Part A**) on the one part and Cheapa Campa on the other part, to rent the Vehicle identified in **Rental Vehicle Agreement Part A** including all its accessories, tools, tyres and equipment as well as any replacement vehicle.

This Agreement (including any addendum or memorandum) shall be read and construed in its entirety and shall constitute the entire agreement between Cheapa Campa and You and shall supersede all other provisions, terms, warranties or conditions contained in any other agreement, brochure, advertising material or representation.

This Agreement shall be governed in accordance with the laws of the State of Queensland in the Commonwealth of Australia. Any actions, claims, demands or suits arising out of or in respect of this Agreement must be brought in the courts in Brisbane, Queensland.

3. Refusal of Rental

Cheapa Campa reserves the right to refuse any rental, or continuation of any rental, at its absolute discretion.

4. Vehicle Condition and Return

- You acknowledge the Vehicle was delivered to You by Cheapa Campa in good operating condition and with the seal of the odometer unbroken. You agree to return the Vehicle in the same condition (except for ordinary wear and tear) together with all tools, tyres, accessories and equipment to the location specified in **Rental Vehicle Agreement Part A** ('the Nominated Location') on the date there specified or sooner, if demanded by Cheapa Campa.
- You acknowledge that the Vehicle is the sole property of Cheapa Campa and that at the time of receipt of the Vehicle by You it was in good running condition and fit for the purpose for which it was required and You ascertained this on your own inspection of the Vehicle and not as a result of any statement or representation made by Cheapa Campa, its employees or agents.
- You acknowledge that the only existing damage to the Vehicle at the commencement of this Agreement is that detailed on the **Vehicle Condition Report**. It is essential that all existing damage is noted on the **Vehicle Condition Report**. Any damage which has not been noted on the **Vehicle Condition Report** will constitute damage which has occurred subsequent to the commencement of this Agreement and You shall be charged for that damage.
- Cheapa Campa in its absolute discretion may take possession of the Vehicle without prior demand to You and at your expense, if there has been a breach of any term of this Agreement or if the Vehicle is illegally parked, used in violation of the law or is apparently abandoned. In such circumstances Cheapa Campa, its employees or agents may enter on any property where the Vehicle is situated and You will indemnify Cheapa Campa, its employees and agents from claims by any person resulting from such entry and retaking of the Vehicle.
- If the seal of the odometer is broken or otherwise tampered with, You will be responsible for not only an extra charge based on 500 kilometres per day at 50c per kilometre, but also for any costs of repairing or replacing the odometer. Additionally, the person/s responsible will be reported to the police.
- If You fail to return the Vehicle to the Nominated Location or return the Vehicle to a different location to the Nominated Location, You will be charged for all costs associated with transporting or towing the Vehicle to the Nominated Location unless otherwise agreed by Cheapa Campa in writing.
- If You return the Vehicle to the Nominated Location and it is not open for business at the time You return the Vehicle, the Vehicle will be deemed to have been returned at the time when that Nominated Location next opens for business and the rental shall continue until that time and the renter is deemed fully responsible for the hired vehicle, unless other arrangements have been agreed to in writing by Cheapa Campa.

Note: Cheapa Campa must be notified and it must agree to any extension of the rental period beyond that specified in **Rental Vehicle Agreement Part A** prior to the return date for the Vehicle otherwise the Vehicle will be immediately reported to the police as stolen.

5. Unauthorised and Prohibited Use

Persons who must not drive the Vehicle:

- A person who is not identified in **Rental Vehicle Agreement Part A**.
- A person who is not licensed for that class of Vehicle.
- A person whose blood alcohol concentration exceeds the lawful percentage whilst driving the Vehicle.
- A person who was driving the Vehicle whilst under the influence of a drug.
- A person who has given or for whom You have given a false name, age, address or driver's licence details.
- A person whose driver's licence has been cancelled, endorsed or suspended within the last three years.
- A person who has held a full open driver's licence for less than two years.
- A person under 21 years of age or a person over 75 years of age.
- A person who uses or intends to use the Vehicle for any illegal purpose.

Circumstances where the Vehicle must not be used:

- Any area outside the Area of Travel shown in **Rental Vehicle Agreement Part A**.
- Any unsealed roads or off road conditions unless authorised by Cheapa Campa in writing.
- Carrying persons for hire, gain or reward, or to carry any inflammable, explosive or corrosive materials.
- Pushing or towing any Vehicle, trailer, boat or other object unless Cheapa Campa has authorised such use in writing.
- Carrying any greater load and/or more persons and/or for a purpose for which the Vehicle is designed and constructed.

- Using the Vehicle for racing, pacemaking, reliability trials, speed trials, hill climbing or being tested in preparation for those activities.
- Using the vehicle in a dangerous or negligent manner.
- Using the Vehicle in contravention of any legislation or regulation controlling vehicular traffic.
- Carrying any animal in the Vehicle, unless authorised in writing by Cheapa Campa.

6. Financial Obligations

Note: You and any additional renter/s and/or driver/s are jointly and severally responsible for compliance with the terms of this Agreement. By entering into this Agreement You and any joint renter/s and/or driver/s are responsible for and irrevocably authorise Cheapa Campa to debit the credit card/s provided (and You will pay Cheapa Campa, on demand, any balance) with the following charges:

- The rental charges specified in **Rental Vehicle Agreement Part A**.
- All charges claimed from Cheapa Campa in respect of parking and/or any other traffic violations incurred during the rental period or until such later time as the Vehicle is returned to Cheapa Campa. It is your responsibility to pay all Road Tolls, this includes in particular the Melbourne, Sydney and Brisbane City Links. An additional administration fee of \$75 per fine / infringement will apply (to cover the costs of processing).
- All loss of or damage to the Vehicle, (including the loss of use of that Vehicle - 'demurrage') legal expenses, assessment fees, towing and recovery costs, consequential third party damage, storage and Cheapa Campa's service charges where:
 - any term of this Agreement has been breached;
 - You have left the Vehicle unlocked or left the keys in the Vehicle;
 - You have not kept the keys secure and under your personal control;
 - the Vehicle is totally or partially immersed in any water regardless of cause;
 - the interior of the Vehicle is damaged regardless of cause except when there is a collision with another Vehicle;
 - the tyres of the Vehicle are damaged other than by normal wear and tear;
 - You have failed to maintain all fluid and fuel levels of the Vehicle or failed to immediately rectify or report to Cheapa Campa any defect in the Vehicle of which You become or ought to have become aware;
 - the Vehicle is damaged by loading or unloading, normal wear and tear excepted;
 - the underbody and overhead of the Vehicle is damaged regardless of cause except where there is a collision with another Vehicle.
 - You have been deemed negligent in any action thereby resulting in damage to our vehicle, a third party or property.

We accept American Express, Visa, Mastercard and Diners Club. American Express and Diners Club will incur an additional 4.5% surcharge on any transaction. Visa and Mastercard will incur an additional 2% surcharge on any transaction.

Note: If You have paid by use of a credit card, or directed Cheapa Campa to bill the charges to some other person, corporation, firm or organisation who or which fails to make payment when due, You will immediately pay the full amount due to Cheapa Campa on demand.

You irrevocably agree and authorise Cheapa Campa to use the credit card/s provided for payment of any amount due under this Vehicle Rental Agreement even if a signed credit card voucher has been returned.

7. Cancellation Fees

If cancelled 25 days or more prior to pick up - \$250

If cancelled 7 to 24 days prior to pick up - 20% of Gross Rental (minimum \$250)

If cancelled less than 7 days prior to pick up - 50% of Gross Rental

If cancelled on the day of pick up or no show - 100% of Gross Rental

As there is no refund for late pick up or early return of any vehicle, Cheapa Campa strongly recommends that you take out your own Personal Travel Insurance.

8. Change of Vehicle

Should the vehicle booked be unavailable through unforeseen circumstances, Cheapa Campa reserves the right to substitute an alternative vehicle without prior notification and at no extra cost. This shall not constitute a breach of contract and does not entitle the renter to a refund. This will include, but will not be limited to fuel costs.

9. Voluntary Downgrade

Should the renter decide to take a lesser vehicle than booked they will not be entitled to a refund.

10. Errors in Rental Charges

Total charges set out in this Agreement are not final. You agree to pay any shortfall in charges to Cheapa Campa.

11. Exchange Rate/Currency Fluctuations

You acknowledge that all transactions under this Agreement are conducted in Australian Dollars. Due to exchange rate fluctuations, there could be some variance between the amount initially debited against your credit card and the amount refunded at the expiration of the Rental Period. You irrevocably agree to release Cheapa Campa from any liability for such variation. Depending on Your Financial Institution, refunds may take up to 15 working days to be transferred into Your account.

12. Conditional Upon Payment

Where applicable, You agree that this Agreement is conditional upon Cheapa Campa being paid by the Travel Agent or Travel Wholesaler who arranged this Agreement on your behalf. You agree that You will pay to Cheapa Campa, upon demand, any shortfall based on the standard gross rental rate for the rental period.

13. Travel Restrictions

- Two Wheel Drive Vehicles:
 - can only be driven on sealed / bitumen made roads or well maintained access roads less than 500 metres long to recognised campgrounds.
 - can be driven to any island, including Tasmania as long as written permission is obtained from Cheapa Campa prior to travel. These areas are considered as remote areas and conditions apply - see clause (d) below.

(b) Four Wheel Drive Vehicles:

- may be driven on unsealed roads on the sole condition that the roads driven on have been gazetted. Gazetted roads are roads that have been named in parliament and appear on official road maps and street directories. If uncertain check with Cheapa Campa before travelling on any unsealed roads. Cheapa Campa has a number of "Restricted Access Areas" whereby written permission from Cheapa Campa is required prior to travelling in these areas - see clause (c) below.
 - can be driven to any island, including Tasmania as long as written permission is obtained from Cheapa Campa prior to travel. These areas are considered as remote areas and conditions apply - see clause (d) below.
 - cannot be driven on The Canning Stock Route, The Lost City in Litchfield Park, to Cape York between the months of December to May inclusive, The Old Telegraph Track on the way to Cape York or the last 2 kilometres of the Lennard River Gorge Road.
- (c) "Restricted Access Areas" are considered remote areas that are unsafe to travel without taking some important precautions such as determining road and weather conditions, hence travelling to these areas can only be with Four Wheel Drive Vehicles and with written permission from Cheapa Campa prior to travel.
- These remote areas are defined as Any Islands, The Simpson Desert, The Gunbarrel Highway, Cape York (North of Cook Town), The Oodnadatta Track, The Birdsville Track, The Tanami Track, The Gibb River Road, The Kalumburu Road, The Warburton Road, The Strzelecki Track, Cape Leveque, The Bungle Bungles, The Plenty Highway, Arnhem Land and any other remote area.
- (d) Remote Area conditions apply to ALL Cheapa Campa vehicles which means in the event of an accident or breakdown in a remote area it will be your full financial liability to pay any salvage, towing and/or recovery costs to the nearest Cheapa Campa branch. No replacement vehicle will be provided under any circumstances.
- (e) Cheapa Campa reserves the right at its sole discretion to restrict vehicle movements in certain areas due to a number of reasons including but not limited to adverse road or weather conditions.

14. Every 500 kilometres

The oil, fluids and coolant levels must be checked by You every 500-kilometres. You must add water/coolant to the cooling system and an appropriate SAE rated oil for petrol or diesel powered vehicles (as applicable) to the engine if the indicator level is below minimum. You agree to maintain the Vehicle in these conditions and acknowledge that any mechanical damage occasioned as a result of your failure to maintain the Vehicle described by this clause will be paid by You.

15. Mechanical Breakdowns

Any mechanical problems associated with the Vehicle must be reported to Cheapa Campa Fleet Maintenance as soon as possible in order to give Cheapa Campa the opportunity to rectify the problem during the rental period. Equipment failure must also be reported to Cheapa Campa. If Cheapa Campa is either not contacted or You do not allow Cheapa Campa the opportunity to rectify the problem during the rental period You agree that the problem is of such a minor nature that You make no claim for loss of time in respect of the rental period. You also agree that Cheapa Campa is not responsible for any claims made by You after the return of the Vehicle.

Note: You agree to be charged a fee where it is established that Roadside Assistance could have been avoided in cases such as keys being locked in the vehicle, flat batteries caused by lights having been left on and other such similar occurrences.

16. Repairs

Any repair up to \$100 needs no authorisation from Cheapa Campa and all that is necessary for full reimbursement to You from Cheapa Campa is a proper receipt for the amount of the repairs. If the repair is more than \$100 then You must notify Cheapa Campa and obtain Cheapa Campa's consent before the repairs are carried out.

If the Vehicle cannot be driven as a result of a breakdown, Cheapa Campa will only reimburse You for the time that the Vehicle was not available for use. Subject to availability, Cheapa Campa will provide a replacement vehicle. However, any cost incurred in you travelling to a Cheapa Campa depot is your responsibility. The failure of accessories such as air-conditioners, awnings, televisions, microwaves, stove and grill, water pump, shower and toilet, refrigerators and radios/cassettes/CD/DVD/video players are not considered a breakdown and no amount will be paid by Cheapa Campa to You. Cheapa Campa is not responsible for any accommodation charges, meals, change of itinerary or out of pocket expenses resulting from a breakdown of the Vehicle or as a result of any accident. You will not hold Cheapa Campa responsible for any insect infestation such as and not limited to ants, flies, cockroaches, fleas, bedbugs and mosquitoes.

Note: It can often be difficult to carry out repairs during weekends and holiday periods and/or in remote areas due to limited opening times and/or spare parts.

17. Tyres/Windcreens

Authorisation must be obtained before tyres or windcreens can be replaced. You are responsible for replacing damaged tyres (for example, but not limited to, blowouts, punctures, sidewall damage, tyre staking etc) unless caused by normal wear. Maintain pressures as per the Vehicle instruction manual. Only purchase new steel radial tyres of the same size and ply rating as is on the Vehicle. If You purchase tyres of a different size or ply Cheapa Campa will give no refund. You are responsible for replacing damaged windcreens. The Liability of the respective Reduction Option will still apply to tyre or windscreen replacement.

18. Child Restraints

You acknowledge and agree that Cheapa Campa gives no warranty as to the appropriateness, correctness or adequacy of any child restraints fitted in the vehicle and that you accept entire responsibility as to the fitting and suitability of any such restraints fitted.

19. Accidents

In the event of an accident You must:

- record the Time/Date/Location
- record the other parties full names, addresses, vehicle registrations, car types as well as any property damage in circumstances where the accident did not involve another motor vehicle.
- record the name of their insurance company
- not admit liability
- notify the nearest police station within 24hours of the accident.
- fully complete and sign the Accident Report Form (which is in the glove box of the Vehicle)

(7) notify Cheapa Campa within 24 hours of the accident and fax through an accident report form.

In the event of an accident, the towing and retrieval of the Vehicle to the closest Cheapa Campa depot is at your expense up to the amount of your **Liability** unless the terms of this Agreement are breached in which event it will be your total responsibility. In the event of an accident there is no refund for monies paid for the unused portion of the rental period.

An administration fee of \$75 per accident file will apply (to cover the costs of processing).

20. General Provisions

- (a) Within 24 hours of an accident or loss involving the Vehicle You must notify Cheapa Campa.
(b) Immediately upon receipt, You must provide Cheapa Campa with every summons, complaint or paper in relation to any accident or loss involving the Vehicle. Compliance with this subparagraph does not excuse You from reporting any accident or loss of the Vehicle to police.
(c) You irrevocably release and hold harmless Cheapa Campa, its employees and agents, from all claims for loss or damage to your personal property, or that of any other persons' property left in the Vehicle, or which is received, handled or stored by Cheapa Campa at any time before, during or after the rental period, whether due to Cheapa Campa's negligence or otherwise.
(d) Except as provided by law, You or passengers in the Vehicle shall not be deemed to be the agent, servant or employee of Cheapa Campa in any manner for any purpose whatsoever.
(e) Cheapa Campa gives no express warranty in relation to the Vehicle. Certain conditions and warranties are implied by statute, whether Commonwealth or State, which cannot be excluded, restricted or modified, such as those under the Trade Practices Act 1974. Where Cheapa Campa is permitted to limit its liability under those statutes for breach of any implied condition or warranty, Cheapa Campa limits its liability to replacement, repair or re-supply of the Vehicle. All warranties, conditions and other obligations which may otherwise be implied are expressly excluded by this Agreement in their entirety. Cheapa Campa is not liable to You or any other person for any indirect, special, incidental or consequential damages relating to this Agreement. In the event of no alternative vehicle being available to the renter our liability is limited to a refund of the hire charge or in the case of mechanical failure (unless caused by the renter) the remainder of the hire period. In the event of an accident no refund will be given for the remaining unused rental days.
(f) No right of Cheapa Campa under this Agreement can be waived except by writing of an authorised officer of Cheapa Campa.
(g) A goods and services tax (GST) or any similar tax, stamp duty or any other tax, a merchants fee, duty surcharge, levy or fee ('charges') may be imposed by local, state or federal government pursuant to this Agreement and collected by Cheapa Campa. In that situation, Cheapa Campa may in addition to the rental charge, recover from You an additional amount on account of the charges. Any additional amount on account of the charges shall be calculated without any deduction or set-off of any other amount and is payable to Cheapa Campa upon demand.
(h) You agree not to part with possession, dispose of, encumber or assign any right or interest in the Vehicle and not create any lien on the Vehicle for repairs.
(i) You acknowledge that Cheapa Campa has not in any way represented itself to You as an entity carrying on the business of insurance. In the circumstances set out in Clauses 29 and 32, You will receive the benefit of Cheapa Campa's insurance cover with its insurer.
(j) You acknowledge that Cheapa Campa requires any information that appears on your driver's licence as well as telephone contact numbers and email addresses to formalise this Agreement. In doing so you also acknowledge that Cheapa Campa will take reasonable care to protect this information, however in the event of its misuse you will not hold Cheapa Campa or its servants liable for any resulting loss or losses.

21. Illustration Disclaimer

Cheapa Campa's brochures, web sites and other advertising material contain only representations of our Vehicles. Pictures, illustrations, descriptions and measurements of the vehicles may be different to the actual Vehicle offered to You due to modifications and/or upgrades. Cheapa Campa is not liable for any such variance.

22. Fuel

The Vehicle must be returned with the amount of fuel equal to that at the time of the commencement of the rental. If the Vehicle is returned with less fuel, the difference will be charged to You at a rate of \$5.00 per litre (which includes a service component).

23. Cleaning

The vehicle must be returned in a reasonable state of cleanliness or You may be charged a cleaning fee up to \$500. If applicable the toilet and waste water tank must both be returned empty or a \$150 cleaning fee will be charged to You in respect to each tank. All vehicles must be completely free of mud. Smoking is not permitted in any of our vehicles or a cleaning & deodorising process will be necessary at a fee of up to \$300.

24. Returns

When open, Cheapa Campa's depot hours are 0800am to 1630pm (local time). The Vehicle must be returned at the Nominated Time and at the Nominated Location. If you wish to change the Nominated Drop Off Location or the Nominated Drop-off Date after the rental has commenced, You first must obtain permission from the Cheapa Campa Head Office. Subject to the change of drop off location being approved, an additional minimum charge of \$700 will apply. If the Vehicle is returned at a different location without permission, the cost of transferring the Vehicle to the Nominated Location will be charged to you, plus a minimum fee of \$700. You will be responsible for the rental of the Vehicle until the Vehicle is recovered and transferred to the Nominated Location. You will also be responsible for any demurrage in respect of the Vehicle. If You return the Vehicle late without permission, You will be charged for the late return at a rate equivalent to double the daily standard gross rental charge, including Reduction Option charge. Early return of the Vehicle does not entitle You to a refund. Cheapa Campa recommends that you take out your own Personal Travel Insurance.

25. Rental Extensions

Should You wish to extend the rental whilst on hire, you must first obtain authorisation from Cheapa Campa Reservations. This is subject to availability. The extra cost of an extended rental must be paid by credit card over the telephone or at a Cheapa Campa Branch immediately on confirmation of the rental extension. The additional days will be at the Gross Rate available at the time of the extension. Failure to obtain authorisation will result in You being charged double the daily gross rental rate.

26. Cyclones/Flooding and Weather Conditions

Cheapa Campa does not accept any responsibility for road closures caused by cyclones, flash floods and other acts of God. Whilst every effort is made to accommodate delays and non vehicle returns to contractual locations any costs over and above the minimum \$700 fee, such as Relocation and Rescheduling fees will be passed on to the hirer. Cheapa Campa again strongly recommends that you take out your own Personal Travel Insurance.

27. Kilometre Allowance

The Kilometre Allowance Per Day and Charge Per Excess Kilometre Fee is indicated on Rental Vehicle Agreement Part A.

The applicable Excess Kilometre Fee is payable by You to Cheapa Campa on return of the vehicle.

28. Satellite Safety Beacon

If You are supplied with a Satellite Safety Beacon it should only be activated in life threatening emergency situations to alert the rescue authorities. Deliberate misuse may incur a severe penalty. Any costs incurred due to the activation of a unit is a matter between You and the search and rescue authorities and shall not involve Cheapa Campa.

29. Damage Waiver Cover

If You act within the terms of this Agreement You will receive the benefit of Cheapa Campa's insurance with its insurer in respect of damage to the Vehicle or third party damage other than any property owned by You (or any friend, relative, associate or passenger) or in your physical or legal control. This however is subject to:

- (a) your payment of the minimum damage or loss of use charge set out in Rental Vehicle Agreement Part A.
(b) You not having caused any other person to have acted in a manner which is in contravention of this Agreement.
(c) You not being covered under any policy of insurance.
(d) You providing such information and assistance as may be requested and, if necessary, authorise Cheapa Campa's insurer to bring, defend or settle legal proceedings, but Cheapa Campa shall have sole conduct of the proceedings.

30. Personal Injury

The Vehicle has third party insurance cover. It is likely that any other vehicle involved in the accident also has third party insurance cover. Depending on the circumstances of the accident, You may be entitled to claim for your personal injury against the third party insurance of the party which is responsible for the accident. The extent of such third party insurance varies in different States and Territories and Cheapa Campa strongly recommends that You take out your own Personal Injury Travel Insurance.

If You are responsible for the accident the Vehicle's third party insurance should cover You for your liability except where You have committed a breach of the Vehicle's third party insurance eg drink driving.

31. Property Damage

The Vehicle is insured for damage to it or damage to the property of a third party. However You are responsible up to the amount of the applicable Liability for the cost of such damage to third party property, or to the rented Vehicle. You are also responsible for the cost of demurrage for the period the Vehicle is unavailable due to repairs. The Liability applies in respect of each claim, not per rental. A second bond will be required if continuing with the rental. In addition to the Liability an administration fee of \$75 will be charged per claim.

The Liability is applicable regardless of who is at fault and must be paid at the time the accident/incident is reported to Cheapa Campa, not at the completion of the rental period.

Note: Personal belongings damaged, stolen or lost are Your responsibility. Cheapa Campa recommends that You do not leave items of value in the vehicle and that You take out Your own Personal Travel Insurance.

32. Liability

33. Bond

For security purposes, only a credit card can be used to provide a Bond. The credit card holder must be present and able to sign for the Bond upon vehicle collection. The credit card holder is jointly and severally liable for any damage to the rental vehicle.

The Bond is fully refundable when the vehicle is returned to the correct location on time, is full of fuel and all other terms of the Rental Contract have been complied with. If there is damage to the vehicle on its return, the Bond will be used to cover the cost of such damage up to the amount of the relevant liability. However, if the terms of the Rental Contract are breached and the Bond is insufficient to cover the damage then any extra cost will be charged.

34. Your Full Responsibility

- At all times you will be responsible for:
• Damage caused to the Vehicle in any way by part or total water submersion be it in fresh or salt water.
• Damage caused to the Vehicle in circumstances where terms of this Agreement have been breached.
• Damage caused to the Vehicle by your wilful conduct eg sitting or standing on the bonnet or roof of the Vehicle.
• Damage caused whilst the Vehicle is being transported over water.
• Damage caused to the overhead and undercarriage of the vehicle.
• Damage caused to or loss of any personal belongings.
• Damage caused by negligence.
• Damage caused by snow chains.
• Damage caused to awning.
• Damage caused by a single vehicle roll over.
